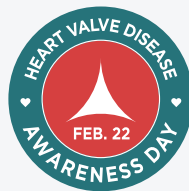

Partnered with the National Foundation for Infectious Diseases to create a fact sheet of common questions and answers about COVID-19 to help distill complex language into easy actionable steps to prevent the deadly virus.

COVID-19 Vaccine Education and Equity Project

Co-led development of national group focusing on federal adherence to robust regulatory review of COVID-19 vaccines, transparency in the review process, and involvement of all key stakeholders at each stage of that process. Led by the Alliance, HealthyWomen, and the National Caucus and Center on Black Aging, Inc., the project involves more than 140 national organizations representing patients, caregivers and families, diverse communities, healthcare workers, older Americans, veterans, frontline workers, and scientists. Partnered with U.S. Health and Human Services Operation Warp Speed to promote older adult COVID-19-specific clinical trial participation in therapeutics, vaccines, and convalescent plasma to the national aging networks.

“Follow the Science” Letter to Public Health Officials

Spearheaded letter published in the Washington, DC-area Wall Street Journal and signed by 79 national advocacy organizations that urged federal health officials to make decisions regarding the COVID-19 virus based on science and not politics.

“Staying Safe at Home” Fact Sheet

Partnered with the National Association of Area Agencies on Aging and the U.S. Administration on Aging’s Eldercare Locator to develop a fact sheet in English and Spanish about staying safe at home during the coronavirus pandemic, which was distributed door-to-door to millions of older adults.

Vaccine PSA

Created and released a new television public service announcement in English and Spanish educating over 60 million people about the importance of getting vaccinated and encouraging people to get a COVID-19 vaccine once available.

“Wear a Mask” PSA

Created and disseminated a 30-second video public service announcement to over 40 million people spotlighting nationally recognized influencers, thought-leaders, and everyday citizens wearing their masks to protect the people they love from the COVID-19 virus.
